Stewart and W. Stewart, the report of Vice Pres. Fordyce on the Welfare Federation and its agencies was very carefully considered.

In our opinion the report represents a great deal of valuable We are unanimously of the opinion that Delegate Fordyce should be complimented on the very able and efficient manner in which he has parried out the work that the Council assigned to him.

We recommend the following changes in the report: First dealing with the Columbia Coast Mission. The report recommends that this agency should be taken over and financed by the Provincial Government. We think that this should be changed to read, "the Dominion and Provincial Governments".

The paragraph dealing with the Seamen and Sailors' organizations. We recommend that this be deleted as what possible changes that could have been made in the direction of the recommendation, have already been made.

Dealing with the Soldiers' organizations: After thoroughly reviewing this section of the report and in view of the fact that they seek and receive funds for charitable purposes, we recommend that this Section of the report be changed to read: "In our opinion the Returned Soldiers' organizations could for the purpose of receiving assistance from the Welfare Federation, centralize their activities for this purpose with the idea of reducing their administrative costs to save as much as possible of Public funds.

Regarding the Returned Soldiers' Club and the difference in the number of the 313 funerals that the report of the Returned Soldiers' Club showed, and the 197 ex-service men buried in Mountain View Returned Soldiers' plot. We have received information that the other 116 were buried in other cemeteries throughout the Province. We have written for the details on this and until definite information is received, we would recommend that we defer action on this part of the Fordyce report.

We recommend the adoption of the Committee's report as amended with the following observations:

Your Executive is of the opinion that all such charitable activities as are carried on by the Welfare Federation rightfully belong to the State. We believe that good government would fully take care of the sick, aged and physically handicapped and that such Social service work is the full responsibility of the Government of the Country and

should not be left to any form of charity.

However, we have to recognize the fact that Governments up to now have not recognized their responsibilities in such directions and that in the meantime some other means have to be found to provide the various agencies with the very necessary monies. Having in mind that we have to meet conditions as they are and not as we would like them to be, we believe that it is advantageous to have our charities organized instead of unerganized. From this direction we believe that the Welfare Federation is doing valuable work. It has eliminated a great deal of overlapping and is rendering a valuable sommunity service.

We would recommend that the Council seek official representation on the Board of the Welfare Federation and that our delegate or delegates to it would then be better able to advance the views and carry out the

policies of the organized Labor Movement.

The tickets are ready and can be secured at the Council office. Hembers and delegates are requested to note that it is vital at this time that they do their utmost in making this 50th Anniversary Banquet a success.

The delegates to the Trades and Labor Congress of Canada convention in London, Ont. reported. Delegate Wilson gave a full report, dealing with the addresses of melcome; that 432 delegates had attended, representing all classes of workers from the Atlantic to the Pacific. Further reported on many of the resolutions, including the resolution dealing with the foreign policy (a copy of which is attached) and the resolution dealing with the suspension of C. I. O. Unions (a copy of which is also attached). It was further reported that in connection with the prosecution of the war, the Convention had instructed the Executive Council to convene a conference of representatives of International organizations engaged in munitions and war supply industries, to lay down a definite policy to be presented to Premier MacKenzie King and members of his Government, under which all workers will be given the legal right to join Trade Unions of their choice for collective bargaining and to guarantee fair and equitable hours, wages and working conditions.

Delegate Wilson further reported on the election of officers; Tom Moore being elected President, R. J. Tallon, Secretary-Treasurer; P. R. Bengough, Vancouver; James Whitebone, St. John, N.B; and Arthur D'aoust Hull, Quebec elected Vice Presidents. That Vancouver had been selected

as the next Convention city.

Delegate C. Stewart reported that he was not in favor of the resolution as passed on foreign policy until such times as a definite statement was secured from the Governments regarding their war aims.

Delegate Bengough reported that following his election he had been sent by the Congress Executive to meet with the Executive Council of the American Federation of Labor in Cincinnati, regarding the autonomy of the Congress in chartering Trades and Labor Councils throughout the Dominion and in representing members of the International Unions in the Dominion of Canada.

"On motion report of the delegates received."

Delegate from the Relief Project Workers Union was given the privilege of the floor and addressed the Council on the many single unemployed who are in need of assistance and that the Youth Council are cooperating with them in endeavoring to register the single unemployed. Also reported that a dual organization is being formed under the wing of the Canadian Federation of Labor and should be condemned.

REPORTS OF UNIONS: -- Milksalesmen -- delegate Showler reported the Meadowsweet Dairy which is operating in the University Area has signed up a Union agreement and is the first cheese factory to produce a Union Made product. The Kingston and Monterey cheeses are now produced under Union conditions and can be purchased in Vancouver stores. Also reported some efforts made to start a dual organization known as the Vancouver Dis-

Civic Employees -- delegate Ashton reported they had passed a resolution that no effort should be spared to heal the breach with the O.I.O. Unions.

Machinists Lodge 182 -- Delegate Oliver reported that they require 20 tickets for the banquet and that the Union is putting up one-half the cost of 2 tickets to all their members who desire to attend the banquet.

Engineers Local 882-Del. Flynn reported good results from their dampaign around the hotels and thanked Beverage Dispensers 676 for assistance rendered. Also that they expect to complete their agreement with the Oewan Dodson Bakery for an increase of wages. Further that they have been endeavoring to get an agreement with the Daily Province but so far have been refused and that unless some improvement is secured definite action will be necessary.

Secretary called attention of the delegates that Brother Cox, Engineers 882-B, had presented the Movement with an original photograph of one of the Tolpuddle Martyrs, Mr. James Hammett, who is an ancestor of Brother Cox.

Secretary moved and Delegate Bartlett seconded that the Council extend a vote of thanks to Brother Cox. "Carried".

On motion of delegate C. Stewart, seconded and carried that the Council go on record as extending a protest to the Federal Government for patronizing the Leckie Shoe Company.

On motion of delegate Shaw, seconded and carried, Secretary to communicate with Governor Olsen of the state of California, extending congratulations for the release of Warren K. Billings.

Brother Tom Shields, representative of the Pacific Coast Metal Trades Council was invited to the floor and addressed the Council on the work of the Metal Trades Department and what they are endeavoring to do to bring about uniform agreements in the Metal Trades. Address was received with interest and appreciation."

The requests of the Relief Project Workers Union were on motion left in the hands of the Secretary with power to a t.

QUESTIONS BY AFABERS: -- Delegate Fordyce asked if the Secretary had received any reply to the letter which he had sent to a Returned Soldier organization, requesting particulars of the burial fund. Secretary replied that no letter had been received.

Question was asked regarding the Workers' Educational Association as to whether they would function this Winter. Delegate Bartlett reported that so far no arrangements had been made.

FOREIGN RELATIONS

WHEREAS, the Trades and Labor Congress of Canada, a year ago, at its Niagara Convention, declared: "We are meeting with the black clouds of war overhanging Europe, threatening to engulf the world, devastating oities and towns, raining bombs and slaughtering women and children",

AND WHEREAS, this Congress further declared for the need and necessity to render help to all democratic countries whose independence and inment to cooperate with other peace-loving countries of the world in imposed by Nazi and Fascist dictators and thus remove the menace of international lawlessness;

AND WHEREAS, we have, in the past, commended our Brothers in Britian and France for their stand in defence of those nations who have been singled out for attack and destruction by dictatorship powers, assuring of democracy and the rights of the workers in any land, they might be in need of our assistance and help, that we would rise to their defence;

AND WHEREAS, in all Fascist and Nazi nations the free trade Union Movement has been outlawed, its property and funds confiscated, its leaders persecuted, in many cases ruthlessly murdered, thousands of its most active members are now in prison or languishing in Nazi concentration camps where dreadful terrorism is being used to break down their health ganizations and institutions, thus destroying not only the Trade Union Movement, but also the medium through which the common people in any of these countries could utilize constitutional and orderly methods to bring about improvement or changes in their social and economic structure, which action constitutes a complete destruction of democracy;

AND WHEREAS, the Trade Union Movement has supported all conciliatory efforts that have been made to preserve peace, which unfortunately have the aggressive action of Germany and her allies from destroying the inexists,

THEREFORE, BE IT RESOLVED, that this 55th Annual Convention of the Trades and Labor Congress of Canada reiterates its stand of former years and Pledges its unwavering support of our membership to the Canadian and British Governments in the prosecution of war against the aggressor nations to the end that the threat of aggression may be removed for all stored to the people now suffering under the heel of dictatorship; and

BE IT FURTHER RESOLVED; in order that the full resources of the Country may be utilized for the achievement of victory, it is essential that profiteering and greed must be eliminated in the production of the sinews we urge that the machinery of production and the wealth of the nation be and corporations, so that there will be an equitable contribution on the part of capital comparable to that of the sacrifice of human life.

We have carefully read and considered the Officers' Report dealing with this matter, the circumstances which faced your Executive at the latter part of 1938 demanded the suspension of the C.I.O. Unions in affiliated with the American Federation of Labor, which have in the past, and do now, represent the vast majority of the organized workers of this Dominion and whose affiliation has over a long number of years assisted to build and give influence and prestige to this Congress.

We find that in suspending the C.I.O. Unions the Executive Council was within its rights and in full accord with the resolutions of the convention of last year which stated: "That action taken shall be on terms acceptable to international trade unions and thus avoiding any roborated by the fact that closely following our last convention the which they themselves have designated as the first convention of the which they themselves have designated as the first convention of the becoming definitely dual to the American Federation of Labor, also changing the relationship with this Congress as it existed at our last convention.

To maintain the strength and authority of our Congress it is essential and necessary that the action of the Executive be confirmed taken in accordance with provisions in Section 7, Article III of the Constitution.
